Additional Rules:

- ★ Dressage tests will be ridden in a 20X60m ring on sand. Tests will be ridden in the indoor arena.
- ★ Warm-up ring will be in the outdoor or indoor arena, where weather permits.
- ★ Lunging will not be permitted in the warm-up ring when occupied by riders.
- ★ Test readers will not be provided but are allowed.
- ★ All athletes must wear approved protective headwear at all times while mounted at the show. This includes both English and Western riders, and applies to warm-up areas as well.
- ★ **Entries may be limited.**
- ★ Each horse and rider combination may ride in a maximum of 3 technical classes per day - does not include Costume Class or Champagne Class.
- ★ No littering, this includes cigarette butts and sunflower seeds.
- ★ All riders must sign a facility waiver.
- ★ No rider 18 yrs or under will be permitted to ride a Stallion on the premises.
- ★ A complete entry will include: Entry Form, Liability Form, and Payment.
- ★ Food and beverages will not be provided nor available on site.
- ★ Champagne class: Riders will be given a glass of “champagne” which they must carry throughout their class. They will be shown at walk, trot, and canter, not to gallop. Riders may ride with one or two hands as per their preference. Riders may show in either English or Western tack. At the end of the class the rider with the greatest amount of “champagne” wins. Ribbons to 4th place.
- ★ All riders and horse owners require current AEF membership.
- ★ Entries will be accepted via email. Email completed entries and e-transfer to burntlakestableevents@gmail.com. Please wait for confirmation of entry form **prior** to sending e transfer.
- ★ We regret to inform you that refunds are not possible after the show closing date of October 7, 2024. However, free substitutions of the horse and/or rider are allowed with a letter from a vet or doctor. Changes to your entry can be made with a charge of \$20/change. This applies to changes in horse, rider, or class. Management reserves the right to refuse changes after the ride times have been published.
